## **Northside Community Law Centre Membership**

Northside Community Law centre (NCLC) is an independent organisation, it is community based and works to develop and educate the community on legal matters. NCLC was set up in 1975 by FLAC. The centre does not impose a means test on its clients but specifies that it is for those living within the catchment area that otherwise would not be able to avail of legal services for reasons of financial, social, educational and psychological obstacles. The catchment area of the NCLC covers a broad area and comprises the electoral constituencies of Dublin North East and Dublin North Central. The centre has a dual role: to provide legal advice and to act as a strategic resource within the community. It works to achieve universal access to the law and to legal services. By employing local expertise and knowledge the NCLC can identify the main areas in the community which are in need of legal services. NCLC provides free information on a wide range of legal issues, advice and in certain circumstances representation to individuals living within the catchment area who ordinarily would not have access to legal services.

You can become either a **full member** (community & voluntary organisations) or an **associate member** (unwaged, students, pensioners) & **supporting membership**.
